### 6. TOXICOLOGICAL PROPERTIES

Route of Entry: Inhalation

Effects of Acute Exposure to Product: Airborne respirable dust may cause irritation to the nose, throat and lungs. Dust particles may mechanically irritate the eyes and impair vision.

Effects of Chronic Exposure to Product: Prolonged and/or repeated exposure via inhalation may result in progressive and permanent lung disorders and damage. Dust has been related to silicosis.

Irritancy of Product: Dust causes irritation as noted above. Skin contact and ingestion are not considered hazardous.

Sensitization to Products: Negligible.

Carcinogenicity: Not considered a human carcinogen.

Teratogenicity: Not established.

### 7. PREVENTATIVE MEASURES

Personal Protective Equipment: An approved (NIOSH/MSHA) respirator equipped with a dust filter, Approved for silica bearing dust, should be worn when exposed to the product under dust generating conditions. Disposable units are normally satisfactory for short-term or intermittent exposure.

The use of additional personal protective equipment varies with severity of conditions. Safety goggles coveralls and protective footwear are recommended when handling bulk quantities of the product.

Engineering Controls: Local exhaust ventilation and confinement of handling systems may be required to Control exposure to dust.

Leak and Spill Procedure: Take steps to control product discharge to the environment. Notify appropriate authorities immediately and arrange for recovery of spilled material.

Waste Disposal: Ensure waste material is disposed of in accordance with applicable environmental regulations, including local requirements.

Handling Procedures and Equipment: Minimize generation of dust during handling. Provide adequate Ventilation. Be aware of dust explosion hazard.

Storage Requirements: Store in dry place. Keep product containers closed or covered where possible.

Exposure limits: The American Conference of Governmental Industrial Hygienists recommends  $\leq 2 \text{ mg/m}^3$  of respirable dust (TWA limit).

### 8. FIRST AID MEASURES

**Inhalation:** Inhalation of dust alone is unlikely to result in an emergency situation. If necessary, use adequate respiratory protection and remove victim to fresh air. Get prompt medical attention if breathing difficulty is evident.

**Eye Contact:** Flush eyes with large amounts of water to remove residual dust particles. Get medical attention if irritation persists.

**Skin Contact, Ingestion:** First aid is usually not necessary.
