VI. HEALTH HAZARD DATA:

ROUTES OF ENTRY: CONTACT, INHALATION, INGESTION.

INHALATION: SINGLE EXPOSURE TO VAPORS IS NOT LIKELY TO BE HAZARDOUS. OVEREXPOSURE MAY CAUSE IRRITATION OF THE RESPIRATORY TRACT.
