SECTION 4. FIRST AID MEASURES

- Notes to physician : Treat symptomatically. Symptoms may be delayed.
For skin effects, a highly efficient therapeutic agent of Pyrethrin/Pyrethroid exposure is topical application of tocopherol acetate (Vitamin E).

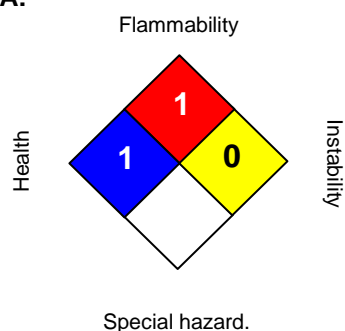
