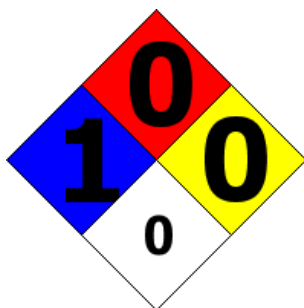

Precautions for safe handling:
