### 4. First-aid Measures



**FIRST AID - INHALATION:** Remove to fresh air. Give oxygen or artificial respiration if necessary. DO NOT use mouth to mouth resuscitation. Seek medical attention.

**FIRST AID - EYE CONTACT:** Flush eyes with water at least 15 minutes. Get medical attention if eye irritation develops or persists.

### 5. Fire-fighting Measures

**UNUSUAL FIRE AND EXPLOSION HAZARDS:** Flammable liquid. Vapors can form an ignitable mixture with air. Vapors can flow along surfaces to a distant ignition source and flash back. Container may rupture on heating.

**SPECIAL FIREFIGHTING PROCEDURES:** Use a self-contained breathing apparatus with full face mask in a positive pressure demand mode. Treat as a volatile liquid fire. Water spray may be ineffective. If water spray is used, fog nozzles are preferable. Water may be used to cool sealed containers to prevent pressure build-up and possible explosion or auto-ignition when exposed to the heat

of a fire.

## 6. Accidental Release Measures

## 7. Handling and Storage

### Personal Protection

### Practical Experiences
